Approval of Minutes: A motion was made to accept the minutes of the July regular meeting. The motion was moved, second and approved all Board members voting yes.

Approval of Requisitions, Vouchers and Bills: A motion was made to approve the bills for payment. The motion was moved, second and approved with all Board members voting yes.

Treasurer's Report: Commissioner Miles reported that the balance in the Investors checking account was \$159,941.19. A motion was made to accept the Treasurer's Report as submitted. The motion was moved, second and approved with all Board members voting yes.

Old Business:

Communications Upgrade: Wall Police has come back with a new price for the radio upgrade. The cost per Fire District is now \$16,500.00. The Township will front the cost, and the District will be invoiced after the first of the year. This cost will be factored into the upcoming Budget.

CAD Paging: Wall PD is moving ahead with the installation. The Fire Districts will divide the cost for the

Districts.

Chief's Office Renovations: Renovations have been completed. The Commissioner's had budgeted \$1000 for materials and furniture. The Chief asked if the remaining money could be used for an computer. The amount not used was \$570. The Board approved the computer purchase.

New Business:

2017 Budget Process: One of the major changes for next year was the purchase of a new rescue vehicle. It was decided that truck 1-88 will not be replaced but will undertake some renovations and upgrades. One of the major upgrades will be a new cascade system. The Director will work with the Chief and the Line Officers as to what equipment can be purchased for the upcoming year.

2016 Assistance for Fighters Grant: 2014 Grant was successful the District got the new SCBA units. The 2015 Grant is still in the cycle to handout awards. The Board deicded to let the Director try to write a Grant Application

on his own without the grant writer.

Wall Township Fuel Pumps: The Town will be installing new fuel pumps. The installation will take about 2 months. During that time it will be an honor system to record the gallons for the vehicles.

Finance Computer: The District QuickBooks computer needs to be replaced. The Board approved to purchase a new computer at a cost of \$420.00.

Second Reading of Resolution: The Board heard the 2nd reading of the Resolution creating the perdium position of Fire Inspector. A motion was made to move the Resolution. The motion was second and approved with all Board members voting yes.
