HOUSE REPORT

Paul Johnson who did the appraisal will contact the Board Attorney about what is required for the fair market price of the Hwy 71 firehouse. This is needed to start the auction process.

EQUIPMENT REPORT

Car 1-67 needs repairs to the headlights and directional, car 1-66 is to go to Seacoast Chevy for service and a rough engine problem. New foot pedal was ordered for truck 1-89. Truck 1-89 will be checked for air leaks.

TREASURERS REPORT

Ed Miles reported that the balance in the Investors checking account is \$151,338.18. On a motion by Norm Stelling and second by Bob Hendrickson all members voted to accept the treasurers report as reported.

CHIEFS REPORT

Chief Newberry reported that for the month of January there were (14) alarms and (2) drills. Feb. 16th will be the company drill. Nothing to report from the SMCFCA meeting. Annual RTK, BBP, HAZMAT, refresher was held. Still need drivers for alarms. St. Patricks Day Parade will be on March 4, one truck and the chiefs vehicle to go, new computer in car 1-66 working fine. Will look into getting new NIFIRS program soon. (2) members attending the Fire Academy. Academy will need truck 1-88 on March 11 and truck 1-77 on April 22. There was a water pressure problem in the West Belmar area, county will install a temporary source to solve the problem. Tankers from Glendola and Squakum will respond if necessary. Farmingdale Fireman's Parade will be on May 28, chief requested if one truck may go to the parade. Wall Fair will be June 28-July1. There will be a parade starting at the 18th avenue firehouse and end at the Municipal Building.
