1. Command/ Staff Vehicles – The new chief's vehicle will be purchased through the Houston/Galveston program. It will be a Chevy Tahoe, 4-wheel drive at a cost of \$47,803 minus the radio and we will reuse the present compter. The vehicle is in Texas and will come from Defender Supply. The announcement of the purchase will be in the Press on February 24. The Ford Crown Victoria will be leased to the Fire Bureau at a cost of \$1.00 a year. Solicitor Sendzik will prepare the lease which will run from March thru December. All Commissioners voted yes to move forward with the purchase and the lease. The Commissioners also approved a \$484.33 reimbursement to Director Newberry.
