Director Newberry reported that the quotes are back for the repairs to truck 1-89. FF-1 Service can in at \$10,980.00 and will be picking the truck up on February 11. Other quotes received were from Defender at \$11,295.03 and Campbell at \$12,645.00. The Board received a quote of \$760.20 for [4] new tires from State Tire for the chief's car. This will be further discussed during the regular meeting. Fire Bureau inspectors are due for new uniforms approval will be addresses during regular session. The generators for the auction still must be moved to the 71 firehouse. The employee contracts are at Solicitor Sendzik's office for approval. The Board is considering moving its banking to Two Rivers Community Bank from Investors. Director Newberry has been in contract with Two Rivers and is working to get the final details resolved. All Board members were given a copy of the 2018 completed LOSAP report for approval. The Board decides to do so. Director Newberry suggested to the Board that they should investigate putting a Bereavement Policy in place. It would follow the same guide lines that are in the Township Handbook. The Board will take formal action during regular session. The Board will discuss during the regular session helping the fire company with the expense of refreshments at certain mandatory drills and the stocking of the cooler in the engine room at the 18th avenue firehouse. Solicitor Sendzik reported on the progress of getting the PERS enrollment finalized. There are still some misunderstandings with the State that his office is trying to clarify.
