## **BOARD OF FIRE COMMISSIONERS** WALL FIRE DISTRICT NO.1 WALL TOWNSHIP NEW JERSEY

September 25 2012

The New Jersey open Public meetings law, N.J.S.A. 10:4-6 et seq., was enacted to insure the right of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interests is discussed or acted upon.

Meeting called to order by Attorney Jay Sendzik at 8:00 p.m. Flag salute followed by announcement of emergency exits Roll Call - Commissioner's Davenport, Hendrickson, Miles, Stelling present at time of roll call. Commissioner Kniffin arrived at 8:11 p.m.

Minutes of the previous meeting were approved as presented. Motion Commissioner Hendrickson, second Commissioner Davenport. Motion carried by Majority.

Correspondence - Subpoena from Freehold Prosecutor's office request for information.

NJ State Association of Fire Districts, Meeting Agenda and Minutes Hose testing report.

Bills - The bills were approved as read on a motion by Commissioner Davenport, second by Commissioner Hendrickson. All members voting Aye.

Chief's Report - [See attached] Motion to approve by Commissioner Davenport, second by Commissioner Hendrickson. All members present voting Aye.

Treasurer's Report - Commissioner Miles reported that the balance in the Checking Account was \$107,575.73. Motion to accept Commissioner Davenport, second Commissioner Hendrickson. All members present voting Aye.

House Report - Commissioner Hendrickson reported grass was cut, company used building for a company drill. No further progress on sale.

Equipment Report - Commissioner Davenport reported truck 1-85 had generator installed. Would like to install electric start on generator. Truck 1-89 problem with out riggers, will be checked by API.

Commissioner Stelling reported that all trucks had hose tested. Lost 4 lengths of 5" and 2 lengths of 3" hose due to holes and leaks.

Bureau of Fire Prevention - Commissioner Stelling reported all materials for Fire Prevention Week received. All inspections up to date, schedule for schools given to chief.

Legislation - Solicitor Sendzik had no new legislation to report.

Apparatus Committee - Commissioner Davenport reported committee reviewed equipment at

Wildwood. Will schedule committee meeting soon.

Inter Local Agreement [Lake Como] - Jay Sendzik reported that have been some more discussions with regard to the Inter Local Agreement with Lake Como. Nothing definitive. Board should act on the Chiefs request to enter into the Mutual Aid Agreement with them from Oct. to Dec. Motion to that affect by Commissioner Hendrickson, second Commissioner Davenport. Motion passes 5-0.

Sale or Route 71 House - Will be listed twice in the Coast Star and Asbury Park Press. Return date will be on Dec 4th at 12:00 p.m. at the 18th ave firehouse.

Up Grade to Security System at 18th Avenue firehouse - No response from vendor. Secretary to send letter to vendor, [System Sales]

Open Public Meetings Policy - second reading. Motion to pass as previously read Commissioner Stelling, second by Commissioner Davenport. Motion passed 5-0.

Blood Borne Pathogen Policy - second reading. Motion to pass as previously read Commissioner Miles, second Commissioner Stelling. Motion passed 5-0.

Audit [2012]- Neral & Company contacted, documents completed. Commissioner Kniffin had not signed approval document. Commissioner Kniffin was given a copy of 2012 Audit and was asked to review by next commissioner's meeting and sign certification. Certification was signed by the four other Commissioners and sent to State.

New Business - Board requested Robert Elliot CPA to give presentation in relation to doing the Board's annual Audit and assisting in doing the annual Budget. Mr. Elliot explained to the Board some of the problems that he found with the Boards audits. After hearing Mr. Elliot's presentation Solicitor Sendzik suggested that the Board decide what they are planning to do as regard to future projects at their workshop meeting. Formal action concerning taking on Mr. Elliot as the Board's Auditor may be done at the workshop.

Personnel Protective Policy - Motion to move on 1st. reading Commissioner Stelling, second by Commissioner Davenport. Motion passed 5-0

Confidentiality and Privacy Policy - Motion to approve Commissioner Stelling, second by Commissioner Davenport. Motion passed 5-0

Emergency apparatus and Vehicle Rules and Regulations - motion to approve and move forward on the revision, motion Commissioner Stelling, second Commissioner Davenport. Motion passed 5-0.

Chief Newberry arrives at meeting 8:55.

Modification and Renovations to Commissioners Room - Jay advised the Board that they have a \$2100 threshold. Anything over that has to be at prevailing rate or union rate. Contractor must also have proper documents.

Solicitor's Report - Will be given under closed session.

Miscellaneous – Commissioner Kniffin said that he had purchased the monitor in the engine room with his own personal funds. Chief will check into the status and location of the monitor. Commissioner Kniffin asked if the District could replace the monitor.

Public Participation – Doug Davenport[Fire Company President] asked for copy of Lease Agreement. Secretary to provide. Asked if Commissioner's could have 71 firehouse lot cleaned. Will schedule meeting between Jay Sendzik and fire company sometime in November. Commissioner Kniffin presented medical bills for Tyler Savage that have not been paid. Chief will handle.

Good of the Board – Chief Newberry reported that the company has 4 members that will be presented a situation from the Fire Marshalls Office.

Motion to go into closed session – Commissioner Stelling, second Commissioner Davenport. Motion passes 5-0. Closed session to discuss pending litigation, there will be formal action taken.

Board approves to go back into open Session

Litigation pending with firefighter Kniffin and Savage. Board agreed in principal but there was no formal action. The Board approved to pass a Resolution Authorizing Litigation Compromise. [See attached Resolution ]

Resolution passed on motion by Commissioner Stelling, second by Commissioner Davenport. Commissioners Stelling, Davenport, Miles, Hendrickson voting Aye. Commissioner Kniffin voting Present on recommendation by Board attorney Sendzik. Motion passes 4-0.

Meeting adjourned at 9:58 p.m.

- I attended NJ State Fire Convention in Wildwood from September 13-15.
  - I am pleased to announce I was elected 2<sup>nd</sup> Vice President of the New Jersey State Fire Chief's Association at their annual conference held in Wildwood on September 13<sup>th</sup>.
  - I attended the NJ State Assoc. of Fire Districts meeting on 9/14. Please see attached documents that were distributed at meeting.
  - Commissioner Davenport, Captain Hendrickson Jr and I will be looked at fire apparatus at the Convention. The Apparatus Committee will be meeting in October to discuss and schedule Demo's to come to the Station for review.
- Utility 85 has returned from Odyssey. Unit is now complete as Captain Hendrickson Jr oversaw equipment mounting upon its return. Unit is now in service as a Tactical Support Unit.
- Four of our Firefighters will be recognized at the Annual Medal Day hosted by the Monmouth County Fire Marshal's Office taking place on Sunday, October 7<sup>th</sup> at the Fire Academy.
- I was contacted by the Chief of Lake Como (S. Belmar) FD regarding mutual aid support since they are having difficulty with staffing and the Borough Council has still not made a decision on the fate of that Fire Department. I would like the Board to consider reinstating the Automatic Aid/Dual Dispatch plan that we had with the Lake Como FD earlier in the summer. I feel it would be best if we offered our assistance from October 1 December 31<sup>st</sup>. Hopefully by then we will have a better idea of what is going to
