Administrator's Report: We have our ESO Solutions Report, we will approve tonight. That is for the new Fire House software system that is a State of NJ requirement. Hose testing and ground ladder testing was completed today.

Equipment: Truck 1-89 has the ongoing odor of coolant. On the last PM it was reported that the EGR Cooler has a leak, and the ongoing air leak problem, The repair of the EGR Cooler is about \$3,500. The Board will look into the problem, and readdress it next month.

ESO quotation is \$12,000 and will be coming out of the communications line upgrade.

House Report: Administrator Newberry had a conversation with the owner of Mr. Shrimp, and explained to him that we had the Township Water Dept. here and they looked at the pit and it is loaded with cooking grease. He said that he would clean it up. The air conditioner in the back office failed and has since been repaired. 18th Avenue fire house all seems to be ok.

Fire Bureau: We had a joint meeting 2 weeks ago. Commissioners Davenport and Stelling attended. Most of the discussion was between Districts 2 & 3 with no impact to our District.
