Administrator Newberry reported on the following:

The Board will be doing a bank transfer of \$12,500, from the Operating Account to the Payroll Account. The Bureau is requesting the purchase of a GTeac Tablet, including installation at a cost of \$3,750.00. James Baily has requested a transfer from the 18th avenue fire house to the Route 71 house. That transfer has been approved.

House Report: there was an issue with the A/C on the second floor. That has been repaired. There will be a cleanup detail later in the month at the 18th avenue firehouse.

Equipment: the ladder truck is out of service again. There are issues with a few things. The truck can still be used as a pumper.

Fire Bureau: Progress

Sale of Surplus Property: Extraction Equipment only to be sold.

Air/Light Unit Remount & Refirb.: The Board will be approving the finance during regular session.

NEW BUSINESS:

- A. Policy Revisions
 - Rules & Regulations of Department Officer: Administrator has met with the Chief Officers and discussed what we are going to do help with the leader deficiency that we have going on at the firehouse. Discuss possible changes to the Rules & Regulations of Department Officers.
 - Mandatory Requirements for Fire Officers: What we're adding will not impact this year's elections. This will impact next years elections. For requirements to run office, within the past three years, prior to the date of nominations, the individual must have successfully completed a harassment class discrimination awareness and prevention training. As offered to the Fire District, or one of the following providers: NJ Learn, NJ Civil Service Commission, NJ Municipal Excess Liability Joint Insurance Fund (MJMEL), NJ Dept, of Labor & Workforce Development, Volunteer Firemen's Insurance services (VFIS), Emergency Services Insurance Program (ESIP), NJ Division of Fire Safety Instructor, NJ Office of Emergency Medical Services Instructor, NJ Division of Law & Public Safety Instructor. Proof of completion is required to be submitted. Such hours may be applied towards the officer continuing education requirement.
