Requisition's – quote for new lights for the ladder truck from Campbell Supply \$3,489.00.80. Batteries for the 2-way radios, (5) radio batteries on NJ State Contract, thru Motorola \$668.75. First part of the Grant we were awarded, Continental Fire (15) fire helmets at \$5,860.00. (12) complete sets of turn out gear \$36,317.40 from Skylands's Area Fire Equipment and Training. Carabineers to carry bags for (3) trucks \$234.75 thru All Hands Fire. (15) harnesses plus a 3 hour in service training session \$4,336.60 thru All Hands Fire. (2) white boards at \$125. Each, thru Power House Signs.

Equipment – truck 1-89 to Campbell Supply. On a request from Commissioner's Davenport and Curtis, Defender came out to check on a reported air brake problem on truck 1-77 and found no safety issues with the brakes.

Fire Bureau – There was a meeting of representatives from all three districts. Eric J. Henderson will be retiring as of July 1 2023. The Bureau will have to bring in additional staff to fill that position before he leaves. It will be a part time position. We will ask for a part time inspector, not to exceed 24 hours a week. We are also looking to advertising for a part time clerical assistant, no to exceed 21 hours a week.

Old Business

- A. Air / Light Unit Remount & Refurb. Administrator Newberry, Commissioner Davenport, Chief Campion and Deputy Chief Rogers attended a meeting on the truck refirb. It was a productive and beneficial meeting. The box truck must be the factor on the start of the day on April 10th.
- B. Grant Award American Recovery Plan Firefighters Grant is being worked on.
- C. Guidelines for response to CO incidents Revision Will be passed during regular session. New Business

A Length of Service Award Program – 2022 – List of all participants who qualified this year.

- B. Fire Museum Work will start on the building and they will need temporary storage of one of their pieces of equipment. Wall Dist. 2 will house a truck, and we will put one in the Route 71 building.
- C. 18th Avenue Station lease renewal The Administrator will have a discussion at the next fire company meeting to explain how the whole lease renewal process works. We anticipate there will be an increase to the lease.
- D. Advertise for Part Time Bureau Positions we will move forward.
- E. Discipline Policy The Administrator has revised the policy after recent discussions. Before the revision the Administrator was going to be the one ultimately responsible for discipline. He is asking that we revise our policy that we are going to establish a disciplinary committee, which will be three people. It is a panel of three, which consists of the following, a representative of the Board of Fire Commissioners, who are not personnel committee members, the second person will be the Chief or Deputy Chief, and the third person will be the President or the Vice President of the Fire Company.

There being no further business to come before the Board at this time the meeting was adjourned at 7:31 p.m.
