- A. There has been an ongoing discussion on an in-house air system. Quick numbers coming back, we will be around \$5,000. This is not something that we budgeted for. The Board will consider this at the end of the year to so if there is monies available for the project.
- B. Hiring of Part Time Fire Inspectors Interviews for the Bureau of Fire Prevention for the part-time inspectors complete. Bureau Committee is requesting to hire 2 parttime. Starting out at a rate of \$18.00 an hour for 21 hours a week.
