**CHIEF'S REPORT:** Chief Newberry reported that for the month of February Fire Dist. No.1 responded to 9 alarms. There were 2 drills, Feb. 22 and Feb. 29, and a total of 6 events. For the month of March, the March 6 drill was cancelled because of weather and there will be a drill on March 27<sup>th</sup>. All members are reminded that BBP, Haz Mat, RTK and fit test must be completed by April 1. We're working with Wall PD on setting up Chief 360 as a dispatch component on the cell phone. The district was successful in receiving the latest round of American Rescue Grant in the amount of \$11,500 for PPE.
