Total budgeted appropriations will increase \$103,526 in 2026. The largest portion of this increase is in total capital appropriations, \$80,500. The projected tax rate will remain the same in 2026 at \$.111. The District will utilize restricted fund balance of \$101,500 and unrestricted fund balance of \$2,500 to keep the same tax rate as compared to no fund balance being utilized in 2025.

- 1.) Fund balance utilized in 2026 will be \$104,000 as explained above.
- 2.) Total operating grant revenue and ARP-FFG expenses will decrease \$11,500 or 100% in 2026. No grants were awarded for 2026.
- 3.) Total appropriations duly incorporated first aid/rescue squad will increase \$6,500 or \$100 to assist the first aid squad.
